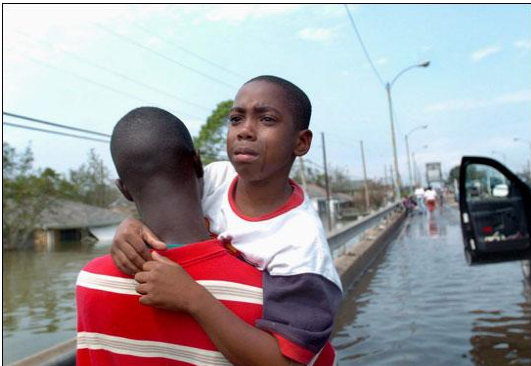

Homeland Security has acknowledged that **Meals on Wheels** programs around the country are the best resource for the care of the senior & disabled population in times of emergencies, community threats and natural disasters.

✓ Meals on Wheels West is an active partner in SMOAID (Santa Monica Organizations Active In Disasters)

✓ Hurricane Katrina – Meals on Wheels West provided 870 meals to the relocated families under the care management of the American Red Cross of Santa Monica.

✓ 1994 Northridge earthquake – Meals on Wheels West provided assistance in contacting family members of our displaced participants along with providing their nutrition and reassurance that someone cares.

Since 1974, Meals on Wheels West has been serving the community's homebound person – someone who is not able to shop or cook for themselves – regardless of age or duration of need. Our vision is to eliminate hunger, isolation and to provide the means to live independently.

- ◆ Veterans returning home from overseas conflicts are a growing segment of the homebound population needing Meals on Wheels
- ◆ Caregivers are increasingly becoming a vital component in our social fabric. Nearly 25% of American households care for someone over 50 years of age. Meals on Wheels West can assist the caregiver by providing daily home delivery of two meals and a caring visit by our volunteers.
- ◆ Any person who is experiencing a life-style change due to age, health or disability or is undergoing short-term convalescing; at-home post surgical rehabilitation—our youngest meal recipient is 25 and our oldest is 103 years young!

Meals on Wheels West can feed a participant in the comfort of their own home for one year for what it costs to stay in a hospital for one day!

MISSION STATEMENT

Meals on Wheels West is dedicated to nourishing and enriching the lives of the homebound elderly, frail, ill, disabled and convalescing person by delivering healthy meals and providing services promoting self-esteem and independent living.

Our Vision is to eliminate hunger, isolation and to foster independence.

For more than 34 years, Meals on Wheels has distinguished itself as a cost-effective provider of nutritious services to homebound person in our community of all ages. Program eligibility requires a demonstrated need for the service, i.e., a disability which inhibits shopping, preparing or cooking meals.

Santa Monica Meals on Wheels was established in 1974 and started with eight clients. In March 1996, we incorporated as an independent non-profit organization gaining our 501(C)(3) tax exempt status. Malibu was added to our service area in 1991 and the Pacific Palisades in 1996. Topanga was added in November of 2001. The program presently serves an average of 250 clients a day.

We rely on public funds, private grants and charitable contributions and funds from the California Area Agency on Aging through allocations from the Federal Older Americans Act and United States Department of Agriculture. We also receive Community Development Block Grants from the cities of Santa Monica and Malibu. Still retaining our independent non-profit status, we do not have age restrictions or any waiting lists.

Our service provides the home delivery of two meals every day, Monday through Friday, one hot entrée and one cold meal. We also provide frozen meals on weekends. Liquid nutrition is available and most special dietary needs are fulfilled. Also available are breakfasts and frozen weekday meals.

Along with our daily meal delivery which provides an invaluable social experience for our isolated clients, we conduct a telephone re-assurance program. Through this program, our clients' needs are monitored. Combined with our daily visits and telephone contact, our homebound clients are assured that someone cares and that they are not forgotten. Through our network of collaborative agencies, referrals may be initiated to address lifestyle condition and needs that we are not able to address.

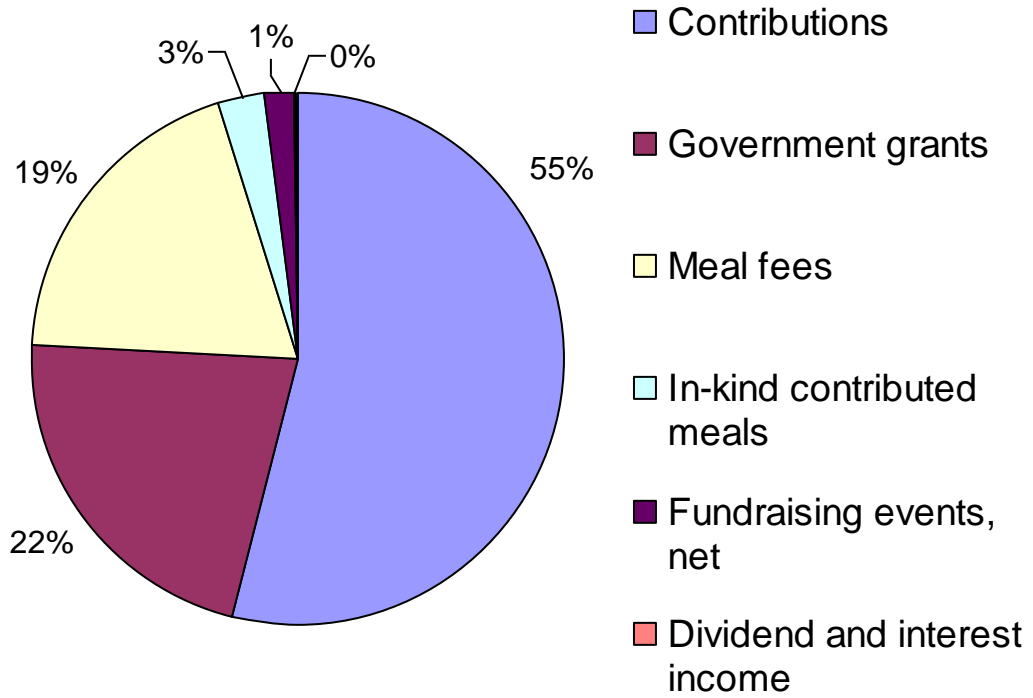
